## Autism Pensacola starts new year with new name

We are excited to announce our new name, **Autism Pensacola, Inc.** The name change took place because we have officially broken away from the Autism Society of America, the national organization under which we originally formed. This change will assure that local funds remain under local control and we continue to fulfill our mission of improving the lives of those living with autism in our area.

Quint Studer, API Executive Committee President, explains, "The national ASA group wanted more control and decision-making. So we elected to go in a new direction with a new name which means the nationally acclaimed Kids for Camp will survive." The six-week summer camp provides educational experiences for children with autism, while they are have fun

learning. Camp includes a week-long training session for the many teachers who work with the children during camp. Many of these teachers take what they've learned back to the public schools where they use their training and share their knowledge with other teachers and aides.

Parents are very happy about this transition. They want the money raised in our area stay in this area, especially to support camp. Autism Pensacola has seen many changes since its inception in 2002 and it has many functions other than the camp. Please see Page 7 for some of the activities which API enjoys.

Jessica Lapen, Chairman of API's Council, says "Autism Pensacola has been a life line to our family. It has put us in contact with people with whom we can share our thoughts about Micah (their 8 year old son with autism) or just to say, 'This is what is happening.' ## API Board Bios

Autism Pensacola is fortunate to have a diverse and distinguished board of directors. We would like to familiarize our membership with those who help "make it happen" in the API organization.

\*\*\*\*\*

Let us introduce board member **ADM Gerald L. Hoewing**, a native of Keokuk, Iowa, who was commissioned an ensign from Iowa State University with a Bachelor of Science degree. He flew the A-7E Corsair II light attack aircraft on multiple deployments to the Western Pacific on USS Constellation (CV-64) and USS Kitty Hawk (CV-63), followed by multiple Mediterranean and Indian Ocean deployments on USS Independence (CV-62) and USS Forrestal (CV-59).

Vice Admiral **Hoewing** was the Operational Test Director for the F/A-18 Hornet aircraft during its initial operation evaluation and later commanded VFA-81 embarked in USS Saratoga (CV-60) during Operation Desert Shield. Additional sea duty commands included USS Seattle (AOE-3), USS John F. Kennedy (CV-67) and Commander Carrier Group SEVEN/USS John C. Stennis (CVN-74) Battle Group.

His shore assignments include multiple tours of duty in the personnel domain ranging from Bureau of Naval Personnel to the Office of Secretary of Defense. Vice Admiral Hoewing's final active duty assignment was as Deputy Chief of Naval Operations (Manpower and Personnel, Training and Education) Chief of Naval Personnel.

Admiral **Hoewing**'s current position is President and Chief Executive Officer, Naval Aviation Museum Foundation, the private fund raising arm of the National Museum of Naval Aviation and the proposed National Flight Academy.

His new book, *Straight A Leadership*, teaches corporations in every industry how to develop standardized leadership practices that ensure success will last longer than individual leaders.

She began her career practicing law as an associate with Troutman Sanders law firm in Atlanta, Georgia.
